MEAL SERVICE DURING CLOSURE OF SCHOOLS DUE TO COVID - 19

Sodus Central School District will be serving breakfast and lunch to its students while the campus is closed due to Covid-19. Meals may be picked up at the Elementary School north entrance, door #9 between the hours of 10:30 a.m. and 12:30 p.m., Monday through Friday from March 18, 2020 through April 3, 2020. Acceptance and participation requirements for the special program and all activities are the same for all regardless of race, color, national origin, age, disability, sex, gender, identity, religion, reprisal, and where applicable, political beliefs marital status, familial or parental status, sexual orientation, or all or part of an individual's income is derived from any public assistance program, or protected by the Department. Sodus has qualified to have the cost of these meals paid for by the federally funded Covid-19 emergency. Meals will be available at the Elementary School as follows:

- **Sodus Elementary School North Entrance Door #8 (Drive-through)**
- Breakfast and Lunch 10:30 a.m. – 12:30 p.m.

Meal service at this location will be for all students in grades PK - 12

Summary of Meal Service Times

- Breakfast will be served from 10:30 a.m. to 12:30 p.m. (pick-up at north entrance door #8)
- Lunches will be served from 10:30 a.m. to 12:30 p.m. (pick-up at north entrance door #8)
